



COMMITMENT TO COMMUNITY FEES

Effective Since January 1, 2011

Commitment to Community programs promote energy conservation and help qualifying households afford the energy they need. All electric utilities in the State of Wisconsin are required to collect this type of fee. The last change in these rates was in January 2011. *This program was formerly referred to as the "Public Benefits Program."*

The State has given us, at the Cedarburg Utility, permission to administer our own local programs with revenues collected including various ongoing programs such as conservation education in our schools, energy-efficiency improvements in local municipal buildings, and bill payment assistance to income-qualified customers. With the revenues collected, we are also able to offer our residential and business customers full access to programs administered through Wisconsin's Focus on Energy program. Cedarburg customers get "the best of both worlds" — local programs and access to statewide programs.

Residential	Rg-1 & Rg-2 accounts: 3.00% of current month's electric bill or \$1.40, whichever is lower.
General Service	Gs-1 & Gs-2 accounts: 2.00% of current month's electric bill or \$2.00, whichever is lower.
Power	Cp-1 accounts: 0.50% of current month's electric bill or \$4.00, whichever is lower.
	Cp-2 accounts: 0.50% of current month's electric bill or \$6.00, whichever is lower.
	Cp-3 accounts: 0.30% of current month's electric bill or \$10.00, whichever is lower.
	Cp-4 accounts: 0.15% of current month's electric bill or \$25.00, whichever is lower.



WATER RATES

Effective January 1, 2015

There will be no change to Cedarburg's water rates in 2018. The last change in water rates occurred in January 2015. You will find our water rates to be quite economical ... starting out at \$3.20 for 1,000 gallons. Clean, reliable, safe and convenient ... right from the tap!

MONTHLY FIXED CHARGE

Fixed charges are based on the size of water meter installed at your location. 5/8" or 3/4" meters are adequate for most homes.

*The fire flow capacity charge shown above covers costs to oversize Cedarburg's water system. This oversizing would not be needed for day-to-day water use, but is needed to ensure adequate water flow in the event that the water system is used for fire fighting.

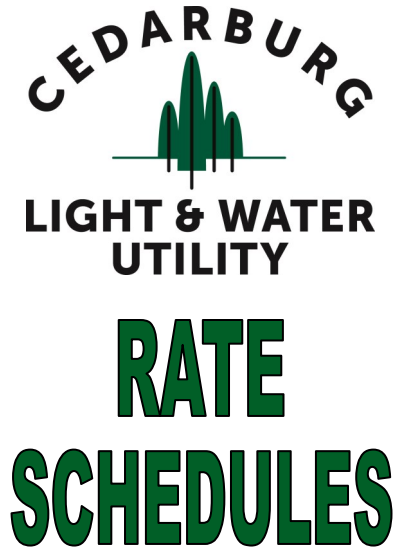

Cedarburg's electric rates are considerably lower than rates paid in surrounding communities, and Cedarburg's water rates are about average. ELECTRIC RATES

Effective Since May 1, 2016

Electricity used in Cedarburg is generated at various power plants and renewable facilities in and out of WI. Changes in the cost to generate power and deliver it to Cedarburg could cause fluctuations in electric costs for our customers. Each customer's change in cost will be included in the line titled "Power Cost Adjustment" on your bill, as that line item covers fluctuations in power generation and transmission costs that are not already included in the line titled "Energy Rate". The actual amount of fluctuation will be influenced by a number of factors such as individual usage, fuel price generation and weather.

There will be no change in Cedarburg's electric rates as a result of the cost to operate the utility and distribute power over local substations, poles and wires. The last change in the local portion of our electric rates became effective 5/1/16.

"Power Cost Adjustment" varies monthly depending how the current cost to generate electricity and deliver it to Cedarburg varies from the average cost that was anticipated in the utility's most recent rate case.



RENEWABLE ENERGY RATES—OPTIONAL

Effective Since January 1, 2008

The energy decisions you make today can support a cleaner environment tomorrow. This is an optional program for customers of Cedarburg Light & Water. Rates shown below have been in effect since January 2008.

Why renewable energy?

- It's clean. The more energy we use from renewable resources, the less we need to rely on fossil-fuel based energy.
- It's secure. Renewable energy is in use all over the country and can reduce our dependence on foreign oil.
- It's sustainable. Renewable energy sources such as wind, water and biogas can never be depleted.

Through Cedarburg's ownership in WPPI Energy, a regional power company serving 51 customer-owned utilities in Wisconsin, Upper Michigan and Iowa, we share generation resources and have access to energy from wind, hydro-power and biogas. You may purchase energy from these renewable facilities by signing up to purchase one or more "blocks" of renewable energy.

Each "block" of renewable energy you purchase is the equivalent of 300 kilowatt-hours (kWhs). For example, if you sign up for two blocks, you will be purchasing 600 kWhs from renewable resources and an additional charge of \$6.00 will appear on your monthly bill. There's no special equipment to install and no difference in the way you receive or use energy at home. Your investment helps to maintain and expand renewable generation facilities. You can change your participation level or withdraw from the program at any time.

ELECTRIC RATE CLASS	CHARGE
All rate classes (Rg-1&2, Gs-1&2, Cp-1, Cp-2, Cp-3, Cp-4, Ms-1, Ms-2 and Mp-1)	\$3.00 per 300 kWh block of renewable energy per month. Purchase one or more blocks. The additional charge appears as a separate line item on your monthly bill. For large business customers opting to purchase 100 or more blocks, discounted rate is \$2.00 per block per month.



NON STANDARD METER SERVICE

Effective Since January 1, 2018

Residents that choose not to have standard meter service on their premises will be charged a non-standard meter reading charge of \$11.23 per month, one charge for electric, water or both.
